IN 2010, THE **NYS DEPARTMENT OF TRANSPORTATION** CONDUCTED A STUDY TO EVALUATE **AVIATION'S CONTRIBUTION** TO **NEW YORK STATE'S ECONOMY**. FOUR COMPONENTS OF ECONOMIC IMPACT WERE MEASURED FOR THE CALENDAR YEAR 2009.

Direct and indirect impacts (related to the activities at the airport) are considered for each component.

COMPONENTS

1.EMPLOYMENT IMPACT: The number of jobs associated with each airport is based on full-time equivalent positions. Two part-time jobs are assumed to equal one full-time job.

2.INCOME GENERATED: Income is the sum of annual salaries paid to workers.

3.FCONOMIC ACTIVITY: Economic activity for on-airport businesses is assumed to be the sum of annual gross expenditures associated with each airport.

4.STATE AND LOCAL TAXES: These tax revenues are estimated as the result of aviation activity.
